# PROMOTION OF ACCESS TO INFORMATION ACT, ACT 2 OF 2000 ("The Act")

## MANUAL IN TERMS OF SECTION 51 OF THE ACT FOR NETTO INVEST (PTY) LTD

### 1 Preamble

The Promotion of Access to Information Act No.2 of 2000, ("the Act") came into operation on the 23 November 2001. Section 51 of this Act requires that we as a private body compile a manual giving information to the public regarding the procedure to be followed in requesting information from us for the purpose of exercising or protecting rights.

### 2 Introduction

Netto Invest (PTY) LTD, formed in 1989, is a firm of independent financial advisors.

We, as a private body, have compiled this manual, not only to comply with the provisions of the Act, but also to foster a culture of transparency and accountability in our environment and to ensure that members of the public have effective access to information in our possession which will assist them in the exercise and protection of their rights.

Inside these pages, you will be able to view the categories of information which we possess. You will also be shown the correct procedure to follow should you require access to any of this information.

Certain information is also made available to employees of Netto Invest (PTY) LTD, which is not generally made available to the public. To avoid confusion, these items are not listed here but may be obtained by Netto Invest (PTY) LTD's employees from Alliot Andersen Nell Incorporated.*

**7 How to request a record, a description of the subjects on which we hold records, and the categories of records held on each subject**

[Section 51(1)(e)]

**7.1 How to request a record**

Requests for access to records held by Netto Invest (PTY) LTD must be made on the request forms that are available from the SAHRC website ([www.sahrc.org.za](http://www.sahrc.org.za)) or the Department of Justice and Constitutional Development website ([www.doj.gov.za](http://www.doj.gov.za)) (under "regulations"). For the convenience of requestors, copies of these forms are included in the version of this Manual available at our offices (Annexure 1).

Requests for access to records must be made to our Information Officer at the address, fax number or electronic mail address provided.

The requester must provide sufficient detail on the request form to enable the Information Officer to identify the record and the requester. The requester should also indicate which form of access is required and indicate if he or she wishes to be informed in any other manner and state the necessary particulars to be so informed.

It is vital that the requester identifies **the right that he or she is seeking to exercise or protect** and **provides an explanation of why the requested record is required for the exercise or protection of that right.**

If a request is made on behalf of another person, the requester must then submit proof of the capacity in which the requester is making the request to the satisfaction of our Information Officer.

**If a requestor does not use the standard form (Annexure 1), the request may be rejected for lack of procedural compliance, refused (if sufficient information is not provided, or otherwise) or delayed.**

Please note that requestors are also required to pay the prescribed fees. **The list of prescribed fees in respect of requests, and in respect of access to records (if the request is granted) is attached as Annexure 2.**

The head of the private body must notify the requester (other than a personal requester) of the prescribed fee (if any) before further processing the request. The requester may lodge an internal appeal or an application to Court against the tender or payment of the request fee.

The head of the private body will then make a decision on the request and notify the requester in the required form.

If the request is granted then a further access fee must be paid for the reproduction and the search and preparation, and for any time that has exceeded the prescribed hours to search and prepare the record for disclosure.

*Kindly note that all requests to Netto Invest (PTY) LTD will be evaluated and considered in accordance with the Act. Publication of this Manual and describing the categories and subject matter of information held by Netto Invest (PTY) LTD does not give rise to any rights to access such information or records, except in terms of the Act.*

## 7.2 Subjects and categories of records held by Netto Invest (PTY) LTD

We maintain records on the following categories and subject matters. **However, please note that recording a category or subject matter in this Manual does not imply that a request for access to such records would be honoured.** All requests for access will be evaluated on a case by case basis in accordance with the provisions of the Act. In particular, there may be applicable grounds of refusal of such a request, as set out in the Act.

*Please note further that many of the records held by us are those of third parties, such as clients and employees, and we take the protection of third party confidential information very seriously. In particular, where we act as professional advisors to clients, many of the records held are confidential and others are the property of the client and not of Netto Invest (PTY) LTD. Requests for access to these records will be considered very carefully. **Please ensure that requests for such records are carefully motivated.***

#### 7.2.1 Internal records

The following are records pertaining to Netto Invest (PTY) LTD's own affairs:

- Founding Statement
- Financial records
- Operational records
- Intellectual property
- Marketing records;
- Internal correspondence;
- Service records;
- Statutory records;
- Internal policies and procedures;
- Minutes of meetings;
- Charters, codes of conduct and policies (both internal and external) to which Netto Invest (PTY) LTD and its personnel subscribe; and
- Records held by officials of Netto Invest (PTY) LTD.

#### 7.2.2 Personnel records

For the purposes of this section, "personnel" means any person who works for or provides services to or on behalf of Netto Invest (PTY) LTD and receives or is entitled to receive any remuneration and any other person who assists in carrying out or conducting the business of Netto Invest (PTY) LTD. This includes, without limitation, members, all permanent, temporary and part-time staff as well as consultants and contract workers.

Personnel records include the following:

- Any personal records provided to us by our personnel;
- Any records a third party has provided to us about any of their personnel;
- Conditions of employment and other personnel-related contractual and quasi-legal records;
- Employment policies and procedures;
- Internal evaluation and disciplinary records; and
- Other internal records and correspondence.

#### 7.2.3 Client-related records

Client-related information includes the following:

- Contracts with the client and between the client and other persons;
- Any records a client has provided to Netto Invest (PTY) LTD or a third party acting for or on behalf of Netto Invest (PTY) LTD (including financial, legal, tax, operational, employee and similar records);
- Any research conducted by Netto Invest (PTY) LTD in respect of its clients or research derived by Netto Invest (PTY) LTD from its clients and their activities;

- Records, reports, designs and the like generated by Netto Invest (PTY) LTD for its clients;
- Any records a third party has provided to Netto Invest (PTY) LTD, which concerns a client; and
- Records generated by or within Netto Invest (PTY) LTD pertaining to the client, including transactional records.

#### 7.2.4 Other Parties

Records are kept in respect of other parties, including without limitation, joint ventures and consortia to which Netto Invest (PTY) LTD is a party, contractors and sub-contractors, suppliers, service providers, and providers of information regarding general market conditions. In addition, such other parties may possess records which can be said to belong to Netto Invest (PTY) LTD. The following records fall into this category:

- Personnel, client, or Netto Invest (PTY) LTD records which are held by another party as opposed to being held by Netto Invest (PTY) LTD; and
- Records held by Netto Invest (PTY) LTD pertaining to other parties, including financial records, correspondence, contractual records, records provided by the other party, and records third parties have provided about the contractors or suppliers.

#### 7.2.5 Other Records

We hold further records, including:

- Information relating to Netto Invest (PTY) LTD's own commercial activities;
- Procurement and administration for Netto Invest (PTY) LTD; and
- Research information belonging to Netto Invest (PTY) LTD or carried out on behalf of a third party.
